Sound Impression (dba Mirage) "Artist", agrees to provide live musical entertainment for the "Venue" according to the details provided above and subject to the terms and conditions listed below:

Terms & Conditions

1. This agreement serves as the only binding instrument for both parties. Deposit (if any) and signed agreement must be returned or this agreement is null and void. This agreement may be cancelled by written notice no less than 30 days prior to the date of performance by either party and will be considered null and void. Should unforeseen circumstances prevent "Artist" from fulfilling this agreement, all deposits and payments shall be returned in full to "Venue" and this agreement shall be considered null and void. Should the "Venue" be prevented from fulfilling this agreement, all deposits and payments shall be forfeited and this agreement shall be considered null and void.
2. In the event of inclement weather during outdoor performances, "Artist" reserves the sole right to cancel the performance at any time on the day of the performance. If cancellation occurs prior to start of performance, "Artist" forfeits all deposits and payments. If cancellation occurs during performance, "Artist" is entitled to 100% of all deposits and payments.
3. "Artist" requires adequate shelter for performers and all equipment from sun and rain for outdoor performances.
4. "Artist" requires at least one 50A electrical circuit in the form of a 3-prong or 4-prong range receptacle. Alternately, three separate 20A standard electrical circuits can be substituted. If a generator is to be used, it shall be a towable, diesel model with voltage regulation. The size shall be no less than 30KW and must have the means to provide the above mentioned electrical circuits.
5. "Artist" shall be allowed one guest per member unless otherwise specified by "Venue" prior to date of performance.
6. "Artist" shall be allowed access to "Venue" no less than two hours prior to performance for load-in and sound check.
7. Any "Artist" equipment stolen or damaged (outside of normal wear and tear or fault of "Artist") while on the "Venue" property shall be the responsibility of the "Venue".
8. "Artist" shall provide sound reinforcement and lighting unless otherwise negotiated with "Venue". If "Venue" is to provide sound reinforcement, the sound tech for the "Artist" shall have control over final FOH and monitor board mixes.
9. Final payment for performance fee listed above is due directly following completion of performance. Payment shall be in the form of cash or check. Checks shall be made payable to "Sound Impression".
